The Logan County Libraries Board of Trustees met in regular session on Thursday, January 16, 2025 at 4:00 PM at the Knowlton Library, Bellefontaine, Ohio 43311.

There was no public participation this month.

The Secretary read the minutes from the December 19, 2024 meeting. Mr. Fansler made a motion to approve the minutes, seconded by Mr. Henry. Motion Carried.

FINANCIAL REPORT

The Fiscal Officer gave the monthly financial report ending December 31, 2024:

- The General Fund showed a cash balance of \$357,427.39.
- The Capital Project Fund showed a cash balance of \$751,765.12.
- The Susie Parker Trust Fund showed a total balance of \$64,948.26.
- The Hazel G Moore Memorial Fund showed a cash balance of \$22,681.43.

Mrs. Goodrich made a motion to accept the Financial Report, seconded by Mr. Tucci. Motion carried.

The Director reviewed the Public Library Fund revenue. She noted an increase in funds of \$19,213 compared to the same period in 2024.
